

## **Delegate Report for March 27, 2021 CLA-WSO Meeting**

The Bylaws Committee is in need of a chairperson. Anyone who's interested in being on the committee or in chairing it, is asked to contact CLA.

The CLArity Committee reported that they're working on the Summer Issue of CLArity and the deadline for articles is April 4<sup>th</sup>, 2021. The committee decided that in the future, the "Ten Years of CLArity" book will only be sold through Amazon. However, CLA is not endorsing Amazon by selling their literature on that site.

The Convention Committee is in need of a new Chairperson. The decision about whether this year's convention will be virtual or in-person will be made at their next meeting on April 25<sup>th</sup> at 6:00 PM.

The Corresponding Secretary reported that during the past month, 21 Newcomer Packets were mailed, as well as 89 other items. There were 89 leaflets sold as digital downloads, as well as 28 mp3s of the 2019 Convention.

The Finance Committee is looking for a new chairperson.

The I.T. Committee reported that the "CLA Literature Collection" has been added as a password-protected digital download and costs \$7.50. It includes the leaflets, booklets and is fully indexed with hyperlinks. Individual leaflets' cost has been reduced to \$.75 per download. An ad hoc committee is working on having our website translated into German, Spanish, and French. A paperback version of the "Literature Collection" will soon be available on Amazon. The committee received 90 emails during the past month.

The Literature Committee reported that that "Ten Years of CLArity" was placed for sale on Amazon for \$12.00. The "CLA Literature Collection," book had problems with formatting so it is being downloaded as a password-protected PDF digital download on the CLA website. Members are continuing to work weekly on analyzing the feedback from members on the Delray Step Workbook.

The Registration Committee reported that the revised interactive registration form is now completed and being reviewed. The committee received 9 emails in the past month.

The Public Information Committee reported that they are still in need of a chairperson.

The Treasurer has no report for this month, but member donations have increased since last month.

The Voice Mail Correspondent reported that during the past 2 months, they received 52 calls for a variety of reasons.

The Odds and Ends Committee is looking for any old CLA documents or emails that were sent in the past, as part of a service committee or group.

The Web Mail Correspondent reported that during the past month, 22 emails were received for a variety of reasons. The Constant Contact email list is now at 1,040 members, an increase of 29 members since our last meeting.

The CLA East Intergroup reported that their new webpage is up and running. They're selling mP3 recordings of speakers from last year's "Clutter-Free Day," for \$3/each or a set of seven for \$18.00.

They're working on this year's Clutter-Free Day, which is on Saturday, May 15<sup>th</sup>. This will be a phone conference. Planning meetings are held every other Wednesday at 8 PM ET. CLA-East meetings are held the second Saturday of each month at 2:30 PM ET. If you'd like to come to one of these, call 866-800-3881 and leave your email address & they'll contact you.

The 8PM Service Committee Intergroup reported that the Newcomer Greeters continue to contact the newcomers who have lots of questions. They're updating the 8PM meeting formats and getting moderators. Last month, the "CLA Equinox Celebration" was registered with them and successfully took place over a weekend, reading the "Ten Years" book aloud.
